## PROSPECTUS

Entrants: Open to all adult artists.

Entry Fee: \$15 for members of Warren County ARTS. \$30 fee for non-members. Entrants may submit up to three pieces of original new artwork created within the past 3 yrs (and not previously shown in a Warren County ARTS show) in the following categories:

1. Oil / Acrylic
2. Watercolor
3. Photography
4. Wild Card (anything not listed above)
5. College Student

For judging purposes, Warren County ARTS may combine categories or eliminate a category from the judging process if there is insufficient number of entries in any one category. Ribbons will be awarded in each category with a cash prize for 1<sup>st</sup> place and Best in Show at the Artist Reception. Generous donated awards from Blick Art Materials, White Space Gallery and Lucinda Chou will also be awarded.

## ENTRY PROCEDURE

Delivery of Artwork on the Drop-off date is in-person only.

Any artwork not meeting the following guidelines is regarded ineligible for participation in the show and will be rejected at the artwork drop-off check-in.

All work must be clean, safe and ready for display. It must be professional in appearance and structurally secure.

Artwork for the gallery's wall space must be properly wired, and not exceeding 7 lbs or larger than 36" x 36". No nudes, no artwork older than 3 yrs or previously exhibited with Warren County ARTS, and artwork entered must be by a currently living artist.

Artists entering sculpture must provide their own professionally constructed pedestal for their artwork.

All works meeting these conditions are eligible for display. Warren County ARTS reserves the right to refuse any work considered inappropriate.

All artwork must have an appropriately attached label, which Warren County ARTS has provided, on the reverse side of this form. Please print clearly.

All artwork must remain on display for the duration of the show.

## DIRECTIONS

The Warren County ARTS' Art Gallery is located inside the Oxford Municipal building at 11 Green Street, Oxford, NJ 07863

From Southern, Western and Eastern Warren County, go to Washington and take Route 31 North to traffic light in Oxford. Turn right at light onto Wall Street. Driveway to Municipal building is on the right, past the firehouse.

From Northern Warren County, take Route 46 to Route 31 South in Buttzville. At the traffic light in Oxford, turn left onto Wall Street. Driveway to the Municipal building is on the right, past the firehouse.
