## PROSPECTUS

**Entrants:** Open to all adult artists. Artists may enter more than three pieces of artwork. Non-members are welcomed.

Photographs must have black or dark frames or unframed if using canvas and photographs must have white, off-white or black mats.

**Entry Fee:** No fee to WC ARTS membership. \$15 fee for non-members.

**Theme:** Anything pertaining to love.



## ENTRY PROCEDURE

Any artwork not meeting the following guidelines is regarded ineligible for participation in the show.

**\*\*\*All work must be clean, safe and ready for display. It must be professionally presented and structurally secure. Artwork for the gallery's wall space must be properly wired and not exceed 7 lbs. The size for wall hanging cannot exceed 36" x 36".**

Artists entering sculpture must provide their own professionally constructed pedestal for their artwork. If the sculpture is too large for existing shelf space and the artist does not provide an appropriate stand, Warren County ARTS will consider that work ineligible.

All works meeting these conditions are eligible for display. Warren County ARTS reserves the right to refuse any work considered inappropriate.

All artwork must have an appropriately attached label, which Warren County ARTS has provided, on the reverse side of this form. Please print clearly.

All artwork must remain on display for the duration of the show.

## DIRECTIONS

The Warren County ARTS' Art Gallery is located inside the Oxford Municipal building at 11 Green Street, Oxford, NJ 07863

From Southern, Western and Eastern Warren County, go to Washington and take Route 31 North to traffic light in Oxford. Turn right at light onto Wall Street. Driveway to Municipal building is on the right, past the firehouse.

From Northern Warren County, take Route 46 to Route 31 South. At traffic light in Oxford, turn left onto Wall Street. Driveway to the Municipal building is on the right, past the firehouse.
