ARTIST RECEPTION is Sunday, Nov 15, 2:00 - 5:00 PM. Due to Covid-19 safety, face masks required & attendance may be staged in 30 minute time slots.

LIABILITY: The artist guarantees any artwork submitted by the artist or agent of the artist shall be the original work of the artist, which shall not infringe or otherwise violate the rights of any third party. The artist agrees not to hold the Township of Oxford or Warren County ARTS liable for any theft, loss, destruction or damage to the artwork submitted by the artist. Warren County ARTS provides all possible care to ensure the safeguard of artwork displayed at this gallery.

COMMISSION: Warren County ARTS receives a twenty-five percent (25%) sales commission on artwork sold through the Warren County ARTS Open Show.

PROSPECTUS

Entrants: Open to all adult artists.

Entry Fee: \$15 for members of WC ARTS. \$25 fee for non-members. Entrants may submit up to two pieces of original new artwork created within the past 3 yrs (and not previously shown in a WC ARTS show) in the following categories:

1. Oil
2. Acrylic
3. Watercolor
4. Pastel
5. Photography
6. Mixed Media* (includes sculpture, pen & ink and charcoal/pencil)

For judging purposes, Warren County ARTS may combine categories or eliminate a category from the judging process if there is insufficient number of entries in any one category.

*List the various materials contained in your mixed media piece on the "Medium Line: in this entry form.

ENTRY PROCEDURE

Any artwork not meeting the following guidelines is regarded ineligible for participation in the show.

All work must be clean, safe and ready for display. It must be professionally presented and structurally secure. Artwork for the gallery's wall space must be properly wired and not exceed 7 lbs. No nudes, no artwork older than 3 yrs or previously exhibited with WC ARTS, no "estate" artwork.

Artists entering sculpture must provide their own professionally constructed pedestal for their artwork. If the sculpture is too large for existing shelf space and the artist does not provide an appropriate stand, Warren County ARTS will consider that work ineligible.

All works meeting these conditions are eligible for display. Warren County ARTS reserves the right to refuse any work considered inappropriate.

All artwork must have an appropriately attached label, which Warren County ARTS has provided, on the reverse side of this form. Please print clearly.

All artwork must remain on display for the duration of the show.

DIRECTIONS

The Winter Open Show will be located in the 5 East Art Gallery in Washington, NJ. The Gallery is co-located with Kathy's Kove at the intersection of Washington Ave and Broad St.

From Southern Warren County, take Route 31 North to Washington. Turn left at the traffic light with Route 31 and Route 57 onto E. Washington Ave. Kathy's Kove is on the left at the next traffic light (intersection of Broad & Belvidere).

From Northern Warren County, take Route 46 to Route 31 South. At traffic light in Washington at the intersection with Route 57, turn right onto E. Washington Ave. Kathy's Kove is on the left at the next traffic light (intersection of Broad & Belvidere)
